

A Message from Mayor Wax

The Long Term Recovery (LTR) Group has not met these past two Wednesdays. But, that doesn't mean that things aren't happening.

Several members LTR were in College Station today to receive briefings on funding updates, policies and procedures.

Last week, myself and other members of LTR were in Austin meeting with the Governor's Office and representatives of FEMA, GLO and Texas Division of Emergency Management (TDEM) to discuss the current situation in Aransas County and plans for long term recovery. I'm happy to report that it was a very productive meeting and that the Federal Coordinating Officer will be visiting tomorrow to get a better understanding of the location and impact of the proposed projects.

These projects/priorities include:

- A Government Plaza Both the County Courthouse and City Hall must be rebuilt. A single location with separate buildings for both government entities, public outdoor space and another building with shared large meeting/judicial facilities, i.e. a single Chamber Hall for meetings, shared courtroom space, jury room and more. This project is a great fit for federal and state grants.
- Little Bay Shoreline stabilization and protection.
- West Harbor Upgrades and improvements, including bulkheads and public areas.
- Small Business Recovery assistance.
- Fiber Optic Loop Stabilize and enhance communications to ensure operation during emergency situations.
- Land for Work Force Housing TxDOT owns approximately 80 acres of vacant land.
 Asking that ownership be transferred to the County for the development of work force housing.
- Long Term Recovery Funding Continue to minimize the use of local entities financial resources.
