**NOTICE** is hereby given that the Rockport Building Standards Commission will hold a Public Hearing on Monday, December 17, 2018, at 5:30 p.m., City of Rockport Service Center, 2751 S. H. 35 Bypass, Rockport, Texas, to reconsider the Building and Standards Commission orders to demolish building(s), for property located at 602 S Pearl St., also known as Doughty & Mathis, Block 61, Lots 15 X 100' of 7 and 8, all 9 thru 16, currently owned by Daniel Jimenez, Rockport, Aransas County, Texas.

Improvement #1 – Total of 2880.00 sq. ft., Main area(s) 4 @ 720.0 sq. ft. each. Car/boat port 4 @ 180.00 sq. ft. each.

Improvement #2 - Total of 1920.0 sq. ft., Main area 1 @ 720.0 sq. ft., Main area 2 @ 600.0 sq. ft. each, Car/boat port 3 @ 180.00 sq. ft each.

Improvement #3 - Total of 1764.0 sq. ft., Main area 3 @ 588.0 sq. ft each., Car/boat port 3 @ 200.00 sq. ft each.

Improvement #4 - Total of 1776.0 sq. ft., Main area 1 @ 768.0 sq. ft., Car/boat port 1 @ 240.00 sq. ft., Concrete 2 @ 128.00 sq. ft. each, Main area 1 @ 1008 sq. ft., Detached storage 1 @ 418.0 sq. ft.

Purpose of the meeting is to review violations of the City of Rockport, Chapter 22, Buildings and Building Regulations, Article X Unsafe Building Abatement, Sec 22-347; conditions constituting a substandard or dangerous building, which includes but is not limited to, unsecured doors and/or broken windows, 50 percent or more damage or deterioration of the nonsporting enclosing or outside walls or covering, damage to structure by wind, or elements of nature. Recommendations; demolition of structures.
