## PUBLIC HEARING BUILDING AND STANDARDS COMMISSION

**NOTICE** is hereby given that the Rockport Building and Standards Commission will hold a Public Hearing on Monday, January 31, 2022, at 5:30 p.m. The meeting will be held in person at the City of Rockport Service Center, 2751 S.H. 35 Bypass, Rockport, Texas, with social distancing guidelines and using the video conferencing application ZOOM. These actions are being taken to mitigate the spread of COVID-19 by avoiding meetings that bring people into a group setting. Video conferencing capabilities will be utilized to allow individuals to address the Building Standards Commission. Members of the public can participate in the meeting remotely by using the ZOOM address that will be provided on the Building Standards Commission Agenda of January 31, 2022, and posted on the City's website [www.cityofrockport.com](http://www.cityofrockport.com).
